General Terms

- All purchases made through our online platform are **final sale** and **non-refundable**, unless otherwise stated below.

Top of the Rock Admission Products

- **Weather Guarantee:** In cases of poor visibility or adverse weather affecting your visit, you may request to reschedule your ticket to a future date or time, subject to availability.

The Rink at Rockefeller Center (including Chalets)

- **All ticket and Chalet purchases are final sale. No refunds or reschedules will be provided.**
- The Rink is an **outdoor venue**. Guests are advised to dress appropriately for winter conditions, including rain and snow.
- **Weather-Related Closures:** In the unlikely event that The Rink closes due to inclement weather, guests will be notified via email and a **refund will be automatically processed**. You may also visit our website for updates regarding weather-related closures.
- Chalet reservations may be subject to minimum purchase or guest requirements. Any such requirements will be disclosed during the reservation process.

Additional Agreements

- Purchasers of Rink products may be required to complete a **waiver of liability**, which is integrated into the checkout process.
